

The night life got old, and after five years he left to work on the waterfront for the International Longshoremen Assoc. (ILA), where he worked for 28 years from 1978 to 2006. ## Meditation for KOC

num 11:25-29; Jas 5:1-6; Mk 9: 38-42, 45-48

If you have a small business or you know someone who does, you may relate to the story of the government official visiting a small business to investigate reports that its employees were being mistreated. He went up to the first person he saw and asked to speak with the owner. The man said: "that would be me".

The agent tells the owner why he is there and he wants to know who the employees are and how they are being treated. The owner says he has 3 employees: One person is in charge of ordering the products they sold and also handles inside and outside sales. He works about 40 hours per week and is paid \$1,000 a week, plus benefits. A second person handles all of the administrative duties. She works about 30 hours per week and is paid about \$800 a week, plus benefits. The agent then asks the owner about the 3<sup>rd</sup> employee. The owner says he likes to call him: Mr. Dummy. He works about 80 hours a week and is on call 24 hours a day. He gets paid on the average about \$2 per hour and the only benefit he is gets is a cell phone so that the office can be in constant contact with him.

"Well", the agent says, "I would like to speak with this man, you call Mr. Dummy". The owner looked him right in the eye and said: "you are speaking to him right now."

This is a perfect lead in to the reading from St. James who is addressing the wealthy of the community, including many business owners. He invites them to weep and wail over their impending miseries. This reading reflects the social and economic situation of Palestine during the first century. The unjust treatment of the poor by those with power and wealth was an ongoing problem in the ancient world.

The situation remains the same today in many respects. There are reports that some of the owners of this country's largest companies are billionaires, yet many of their employees are underpaid. Are these the people who James is addressing?

The important point is that it is a Catholic Doctrine for employers to eliminate injustices in the workplace. This is done every day by the many, good, Christian business owners we have in America, sometimes to their detriment, in order to keep the company going and their employees working. Another Catholic Doctrine is that those who have an abundance are obligated to use it in the service of others. this is basic to God's law, the law of love.

Moses and Jesus are faced with similar problems. Their key people are complaining about persons, not from their inner circle, who were doing things in their names. Both say not to stop them. in our Reading from Numbers, when two men, outside their inner circle, began to prophesy, Joshua asked Moses to stop them but Moses declined. In fact, he said he wanted more people to be involved.


In Mark's Gospel, St. John expressed concern that some unknown person was casting out demons in Jesus' name. Jesus tells John that he does not have a problem with someone who performs mighty deeds in his name. He said: "do not prevent them". Jesus points out that by doing the great deeds of exorcism in his name, the person is really receiving his power from God. Jesus says; "whoever is not against us, is for us".

Was jealousy driving the complaints of Joshua and John? Were they thinking: "we thought we were the only ones appointed to do these works"? But Jesus would have none of that. Like Moses, he wanted even more people to be involved. Some churches may have a problem with people who do so many ministries for the churches that they keep good people from participating in churches' activities. Like Joshua and John, they do not realize that participating in the churches' ministries is the job of everyone.

Another problem happens when people do not participate in their church's ministries because they think that serving the church is not for them. We need to realize it is everyone's responsibility to be involved in our church's ministries.

We need to remember that great deeds are not always expected of us. Even the smallest courtesies performed in Jesus' name will be rewarded, even as small as giving a thirsty person a cup of water to drink.

So what can we take from our Meditation? Use the blessings wisely that God has given us to benefit those who are not as fortunate as us; Become more involved in your church and encourage others to do so. Remember, even the smallest task done in the name of Jesus will be rewarded.
